## Recycling

Beginning in November 2019, the large recycle bin that is currently located near the city shop, at the southeast corner of town, will no longer be available for use. The city will soon be mailing out informational postcards courtesy of Waste Management. These postcards will have all pertinent information regarding the new recycling program. Please keep an eye out for these in your mail next week. We are moving to **CURBSIDE** recycling. The reason that the city made this decision is due to the misuse of the large bin. This will allow for Waste Management to individually address and educate you if there is something that is not recyclable in your recycle bin. Every household/ business, within the city limits, will receive their own 96-gallon cart. This cart will be picked up every other Tuesday. The first pick up date will be **Tuesday, November** 12th and then again on **Tuesday, November** 26th.

## **Library Board**

The Collins Public Library Board of Trustees is searching for a new member! Requirements and things to keep in mind for this current open position are as follows. #### **Improvements to the Community Center-** Brett Comegys

Councilmembers Dawnell Kennedy and Staci Corbitt put together some suggestions to the council regarding improvements to the community center. These upgrades are focused on the back portion of the building... replacing paneling with drywall, kitchen improvements, southern windows, etc. The conversation has evolved to the possibility of adding a new addition to go along with those improvements. While we are still finalizing some of the details on what that addition may look like, the idea to build will give us a chance to create a dedicated space for our Historical Society, enlarge the kitchen, and to install needed storage space. Considering how vital this location is to our town, the investment seems like it would do a lot of good.

With the larger project in mind, I submitted a \$25,000 grant request to the Story County Community Foundation (SCCF). Expansion of the Mural Walk was also included in the grant language. My personal fundraising goal is \$40,000, which I think will do some great things.

Out of 21 letters of intent around the county, Collins and 3 others were invited to submit a full application. Collins did not get the \$25,000, but we are going to be awarded \$14,000 as a consolation. Along with that, I have applied for \$2,500 from SCEDG (Story County Economic Development Group) and \$5,400 from the Albert and Vera Clement Foundation. In addition, the Collins Days Committee has allocated \$1,500 to the project. There are also several other revenue sources that I have reached out to, but I am still awaiting news or a final commitment from.

I am confident that we can reach that \$40,000 mark within a few months. As I say that, we still have a lot of discussions to have... and a lot of different opinions to consider on exactly what this project's endgame will look like. All I can say about that is that conversations are usually a lot more productive when you already have guaranteed money set aside... which is why I am getting a head start on raising money.

We still have a lot of flexibility in this project. There has been some great input from a few people already, and this newsletter is an opportunity to solicit even more ideas. So, feel free to share. Your input might help us think up something that hasn't been thought of already.

As this project progresses, we will keep everyone informed. Thanks.

#### Tax Increment Financing (TIF) and Collins- Brett Comegys

Many of you that have been reading newsletters over the past few years probably recall hearing something about TIF. This was something that I brought to the council 5 or 6 years ago to try and have them start wrapping their minds around. Initially, those conversations weren't really intended to get the council to adopt TIF practices, but simply to help everyone digest the potential of what it could do for us. Since that time, we have had a lot of new faces join local government... allowing us to jump start those discussions again, and open the door for much more meaningful action on the topic.

As a reminder, TIF is actually something called "TAX INCRE-MENT FINANCING". The practice has been around since the 1960's and is nothing new to local communities. In TIF, an entity works to identify specific properties that are earmarked for development. As those properties improve, so do their assessed tax valuation. These have to be mapped in an Urban Renewal Plan, and approved through a legal process. Once complete, if these properties do improve, the increased tax collection they provide can be captured by the entity who wrote the plan... and instead of being split between the state, county, school, and city they are in, the revenue goes to the projects mapped out in the plan.

So, in the case of Collins, we put together a renewal plan that identified a number of properties in town. Some of those properties were empty lots. Others were once publicly owned but were now going to private ownership. The council retained a lawyer to help us ratify the plan, send out notices, etc. We will be able to capture the revenue generated from the increased value of properties within the plan, and use that money to tackle projects outlined in our plan. In our case, we have designated our roads as the priority. (But the plan can be modified later to involve additional projects.)

None of this affects your taxes. Simply put; if a property is worth \$10,000, the owner is paying property taxes that go four different directions. If that owner puts a \$100,000 home on that land, the increased value (\$90,000) is now bringing in new revenue that didn't exist before. That is the revenue that our plan captures. With the projected revenue, we go out and shop for debt that is backed with those expected revenues, and we use that debt to do our projects. The debt is paid back yearly from the TIF revenue. We can collect that revenue on residential improvements for up to 10 years, and commercial improvements for 20.

The reason that we never used this option before is because we

just weren't ready for it. A change in clerk, an administrative consultant, and a willing council have all contributed to the right environment. But in reality, we just weren't ready to support enough development for TIF to make sense. With some of the houses going up, selling of public properties, and buildings being torn down, we are in a far better position.

Most importantly to TIF in Collins, though, is the development of the new LANDUS facility, just outside of town. Through some excellent investigative work by Councilman Del Amsden, we found out that Collins has the ability to include TIF improvements that fall within 2 miles of our City limits. This is a big deal, because it allows us to TIF the LANDUS operation and thus add millions of dollars in new development to our Urban Renewal Plan. So, Del was a real hero in the process, because LANDUS will add about \$160,000 to the TIF coffers per year. Adding LANDUS is the equivalent to about 50 new homes going up. This will make a real impact on our town and I hope people can get excited about all of the changes that it will bring to Collins.

#### Mural Committee- Brett Comegys

I have been meeting with the mural committee and I am happy to report that we have finally come to an agreement! We agree that we cannot agree. Putting a positive spin on this is pretty easy... because this is actually a positive and it means that there are just too many great things about our town that people would like to see represented on a mural. As a compromise, I suggested that maybe we shouldn't limit ourselves to any one idea. Thus the concept for a "mural walk" on Main Street was born. The council liked the idea and opened the door to development. We believe it will make a wonderful stopping point for folks traveling

through town on the Heart of lowa Trail, for those visiting our businesses, and for everyone that lives here and wants to celebrate our local heritage. For anywhere from \$300 to \$600, people can sponsor a vinyl mural, celebrating our town's past, present, and future. To help kickstart the idea, my family contributed to the first two. Hopefully, this will inspire other folks around town to want to financially support additional items to be added to the area. Together, I think we can all be a part of creating something really unique and special in Story County.

I have had some preliminary conversations with a couple of members of the Collins Historical Society, as well as others, to help come up with mural ideas that we can put out there for sponsorship. If you or someone you know would like to help finance one of these signs, please contact City Hall and they will put you in touch with me. The Mural Committee will be meeting sometime in the future to continue our conversations about the matter, as well. An added note... there still may be something going on the Hair Hut wall. This is still an ongoing discussion and we can all look forward to seeing where that conversation goes.

#### **Competing for Grants and our General Fund-** Brett Comegys

Over the past 7 or 8 years, Collins has been extremely competitive with grants. Grant awards range anywhere from \$500 to \$840,000. In all, we have brought in well over \$1.6 million... and are on pace to add another \$60k to that number this year alone.

Please understand that these outside funding sources have been extremely important to our efforts of repairing infrastructure, cleaning up Main Street, and doing a lot of other things around town. With such a tight budget, Collins would be in a much different place than we are today if it weren't for these sources of income. So, no matter how we move forward, being able to raise money is going to be a continued necessity if we want to keep making improvements to our town.

Speaking to a specific grant, the City of Collins has just been awarded \$23,000 to help us build a new retention pond on the edge of town. Between the generous terms that were offered from a local land owner, the work of past councils, the vision of our current council, and the support of city staff,... we are set to make the next set of improvements to our stormwater system. When I initially presented this grant request to the Board of Supervisors, it looked like we were getting a door slammed in our faces. To their credit, they were open to additional conversations with me and everything seems to be on track. It looks like another big improvement is on the way.

#### **Cindy Kendall-** Brett Comegys

One of those grants has allowed us to hire the services of Cindy Kendall. Cindy, since her retirement from the State of Iowa Outreach and Extension office, has been working with small communities like ours to help better educate cities on budgets, office training, and other vital functions of Iocal government. Early this year, I reached out to her and asked her to put together a proposal and possibly sign on to help us out. She is a wealth of information and we are extremely lucky to have her. Her expertise is a wonderful asset as we move toward TIF and helping us navigate the transition from one clerk to another.

As an added note to this topic, Jay Christie has worked very closely with Cindy to comb through our budget. Between Jay's background, and Cindy's

#### Junior's General Store- Brett Comegys

Junior's General Store had their grand opening on October 6th and had an estimated 150 people show up. It was a pretty good crowd considering we only had a couple of flyers up and one Facebook post. Thank you to everyone that showed up and supported the event!

Hours of operation are M-F from 11-2 and 4-7. The store is being staffed by volunteers and only accepts cash and check for the time being. Quick meals, milk, bread, and other basics will be available. Prepackaged foods that have been prepared at separate licensed locations can be sold there, which include canned and dry goods, milk, bread, and some local novelties such as: Smuck's Kringla, Clear Creek Orchard jams, Salt Lickers Spices, Logsdon's sandwiches, Gym-N-Eat Crickets, State Center Locker meat, Zeb's Smokehouse products, and George's Pizza.

2006 is when Kum N Go closed its doors. Within the last year we have managed to get a gas station back in town... and now we have a place to get basic food items and other goodies. My wife and I are excited that we have been able to put this together and we are hopeful that it'll be a help to folks living in the area.



#### Senior Housing Committee- Brett Comegys

Last year the senior housing was sold to a private owner, giving the committee that managed the housing complex the ability to use the proceeds toward various non-profit causes around our town. They have been instrumental in adding new park equipment at the Trailside Park, buying trees to be planted, helping tear down some of the old houses in town that needed to go, and much more.

Starting the senior housing project years ago was a huge plus for our community, but doing the work they have been doing

#### Rumored Audit- Brett Comegys

The City is NOT under an audit. The state schedules cities in lowa to go through a mandatory audit every 10 years or so. They come in and do a walk through of the books, spend a couple of days making notes, and then give a report on what might need corrected. Collins had one a few years ago and is not scheduled to have another one any time soon.

A few months ago, we got a new clerk. She has been going overboard trying to reconcile problems with our software, learning new systems, and trying to get a handle on our financials. Based on discussion with Cindy, it made sense to me that an audit would actually come in handy right now, so that we could start Katie off with a fresh start. So, I asked Cindy to check with the state to see if we were on a list, and if we weren't, what it would cost to have them come in and go through our books. With that, Cindy came to the council at our last special meeting and reported that even though state audits are free when they are mandated, requested audits actually cost somewhere between \$5,000 and \$10,000.

As a continuation of the discussion, Jay Christie asked Cindy what kind of services she could provide as an alternative to paying for the state's review, and what those services might cost. Cindy said that she would put together a proposal and present it at the next council meeting.

I know that there have been some other versions of this topic... but those are not accurate. We are not under any kind of audit and we have not been contacted by anyone or any agency to discuss an audit. The entire topic was prompted by my discussions with Cindy, and any decision to move forward with such a review will be at the sole discretion of the City Council. No decision has been made on this issue, but when one has been, the City will be sure to give everyone an update.
